- Bank Balance continues to increase year over year. Balance at Dec 31, 2023 \$51,444.33.
- All ledger's, bank books, cheque stubs and bank statements prior to 7 years have been shredded as it's unnecessary to keep them.

Membership – Yvonne Halkow (absent – full report attached)

- Total membership 137 year-to-date 2024
- AB - 23, BC – 23, MB – 14, NB/PEI/NFLD – 5, ON East/Quebec – 18, ON South – 27, ON North – 3, SK – 13, NS– 6, Foreign – 5
- Starting in 2024 for 2025 membership, renewal fees are \$20 for all member types.

New Business

The 2024 National Specialty was held in conjunction with the Manitoba Canine Association all breed show and Winnipeg Area Shetland Sheepdog Association Specialty. It was very well run, and we give a special thanks to the WASSA members for their hard work in pulling all the events together. We are now looking for hosts for the 2026 National Specialty.

Membership Involvement

Member participation has been an ongoing dialogue for many years. In response, the board recently streamlined member renewal processes and reduced associated fees however, further action must be considered.

The executive will review these suggestions in upcoming board meetings.

An open discussion by meeting attendees followed covering the lack of volunteers to sit on the Board, hold National Specialties, along with member retention and growth. Incentive suggestions brought forward at this meeting were:

- 1) Free membership for first time puppy buyers, in which the breeder is their sponsor, they have a 2-year probationary term where they can't vote
- 2) Discounts for members for seminars
- 3) Reduce membership renewal fee
- 4) Funnel money to the National account from seminars to ease burden on host clubs
- 5) First year of membership free without voting rights

National Advisory Committee (NAC) (see attached report)

A National Advisory Committee (NAC) was established in February 2024 to develop national specialty support processes. The President and the Treasurer are compulsory executive members as they hold primary responsibility for CSSA finances.

The 2024 National Specialty commitments are to pay for ribbons, all CKC fees and associated Show Secretary Fees. The NAC will continue to consider strategies to alleviate the organizational and financial burden on host clubs.

Treasurer's Report for 2024 AGM**General notes:**

Each year, the annual Treasurer's Report is sent out to all members, and includes four elements:

1. Treasurer's Report for the year
2. Transaction Report showing the changes in our bank balance from Jan 1 to Dec 31 and includes complete lists of every receipt and disbursement for the year. Having the complete lists allows any member to review all the club's transactions if desired.
3. CSSA financial statement for tax purposes
4. CSSA complete tax return

2022 highlights:

2022 was very much a transition year where Pete continued to maintain the records for the Treasurer's position. Membership was up from \$3387 in 2021 to \$4154 in 2022. 2022 was our last National which brought in a huge surplus of \$13,846.26. With disbursements totaling \$4002.50 we had an amazing financial gain of \$14,387.85. Bank balance at the end of 2022 was \$48,958.75

2023 highlights:

I took over from Pete in early 2023 after Pete kindly submitted the 2022 tax return. Bank account was changed from Meridian to TD Canada Trust. The decision was also made to do away with the American currency account. Our foreign members cheques are accepted by the TD Bank.

As membership amounts were reduced our membership income was \$3,193.49 in 2023. Our bank account had receipts of \$4,048.36 and disbursements of \$1,561.78 leaving us with a healthy balance of \$51,444.33 at the end of 2023.

All account ledgers, bank books, cheque stubs and bank statements older than 7 years have gone to the shredder as there was no point in hanging on to them and it was an expensive, heavy package that I received from Pete.

2024 National Sweepstakes Judge's Critique

Thirty-seven years after I was introduced to this breed, I had the tremendous honour to Judge Juvenile and Veteran Sweepstakes at the 2024 CSSA National. I thoroughly enjoyed the atmosphere of the show, the venue, the organizers and my ring steward who kept me on task. My sincere gratitude to the exhibitors who entrusted me to offer an opinion on their dogs.

JUVENILE SWEEPSTAKES

I was thrilled with the quality packed youngsters that walked in the ring. The outlook is bright for these beautifully presented dogs and regrettably many deserving dogs left without the big wins. The breeders of these dogs should be extremely proud.

In general, the majority of the dogs had age-appropriate structure. Many with good fronts, angulation and movement. Some heads still need time to get the fill of muzzle and underjaw. A few had sloping stops giving the appearance of too much head length. There very few where the "parts" didn't seem to go together and as juveniles that's not easy to accomplish. Breeders and owners are doing a stellar job with temperament and training dogs for competition.

My Best in Juvenile Sweepstakes, Amberylyn's Animation, is a striking, well-proportioned dog from the 12-18 month class. What a pleasure to watch him strut confidently into the ring, with feet landing correctly to display his overall balance. Masculine yet light, clean head with appropriate stop to exhibit equal length, parallel planes. Lovely eye, level topline, length of neck and back, and very good angulation. He moved effortlessly in all directions. He was a standout on this day and very deserving of the win. The future is bright for this boy.

My Runner Up to Best in Juvenile Sweepstakes, Shadland Simply Legendary At Emmy, is an impressive boy from the 9-12 month class. He has a pleasing correct eye, smooth clean head and lovely ear placement all drawing you in to a charming expression. A level top-line with balanced structure and lovely side-gate. He is a very promising dog to watch as he matures.

VETERAN SWEEPSTAKES

The veterans were so special to judge. Each of them in remarkable, age-appropriate condition proving why they are still competitive and winners in their own right.

My Best in Veteran Sweepstakes, Suntime Anything Is Possible, is a stunning, balanced bitch from the 7-10 year class. Excellently conditioned, she moved effortlessly and always placed her feet solidly where they should be. Detailed, well-proportioned head with a pleasing expression. Well-fitted, correct coat. She exudes type and overall balance from all angles. What a delight to have her grace the ring.

My Runner Up to Best in Veteran Sweepstakes, Attridge Hugo Boss, is a masculine, impressive male from the 7-10 year class. Stately outline and lovely length of neck all presented proudly on a well-set front. A clean, well-proportioned head with fill of underjaw and parallel planes. Abundant, correctly textured coat. He has a noble manner about him that calls for respect.

It's evident that Canadian Sheltie breeders and owners are doing things right and I'm so appreciative to be part of the community. I sincerely loved this very special assignment!

Judge's Critique
2024 National Specialty Conformation Show

Judging the recent Canadian Sheltie National was an immense honour and a rewarding experience, providing a unique opportunity to judge the breed I hold so dear to my heart. The Canadian Sheltie National showcased an impressive assembly of quality Shetland Sheepdogs, highlighting both exceptional breed characteristics and strong breed type. The overall standard of the event was commendable, reflecting the dedication of breeders and exhibitors committed to preserving the integrity of this beloved breed. I observed a diverse array of entries, with numerous dogs exhibiting excellent structure, movement, and temperament. The fluidity of their gait and the harmony of their movement were particularly notable, reflecting both the athleticism and grace that the breed is known for.

Class dogs were limited in number, but the quality was great. The winners dog was a moderate sable with a beautiful expression and outline. He was a young dog, but carried himself well and covered ground when moving. He had a solid build that complemented his size, and his proportions were well-balanced. The winners bitch was beautiful in breed type and filled my eye completely. She had a beautiful correct outline, expression and movement. She had pretty details on the head and the eyes were melting with a keen expression. She was in beautiful condition and mature. The quality of the specials was really impressive. After sorting through all of the specials, I noted the quality was deep and details were going to be important. When sorting the specials, type was most important in my decision. From the dogs that had the type that I preferred, details were then examined. Many of the dogs had beautiful heads and expressions including proper ear set. Shoulders were top of my list and I was looking for proper layback and tight elbows and was pleased to find so many with nice fronts and rears. The final decisions were based on closer examining of details and specific breed characteristics since the quality was so good.

If my observation of the club, the camaraderie flourishes and the commitment and shared compassion was noticeable. Each member was contributing their strengths and experiences working side by side helping elevate our breed. It was so impressive to see a supportive community where everyone worked toward a common goal.

My biggest joy of judging the Canadian Shetland Sheepdog National was the large entry of Junior Showmanship. All age groups were well represented and there were so many of them with unchartered talent.

The Jr's were all professionally dressed and had nicely groomed dogs. I hope they continue to master their skill of handling dogs and continue in the world of purebred dogs.

Overall, the Canadian Sheltie National was a resounding success, showcasing the best of what this breed has to offer. The quality of the dogs, adherence to breed characteristics, and commitment to maintaining breed type were evident throughout the event. As breeders and exhibitors continue to strive for excellence, the future of the Shetland Sheepdog in Canada looks promising. Changes:

CSSA CODE OF ETHICS

CSSA Fanciers Inc (the Canadian Shetland Sheepdog Association) considers these as guidelines for ethical dog-related practices in the areas of breeding, buying, selling and exhibiting the Shetland Sheepdog. Membership in this Association assumes a responsibility above and beyond the requirements set out in the By-Laws and Code of Ethics.

1. Members shall promote friendship and cooperation among breeders, owners, and exhibitors of Shetland Sheepdogs and assist them for the benefit of the breed.
2. Members shall not speak on behalf of the Canadian Shetland Sheepdog Association unless granted permission by its Executive.
3. Members shall strive to educate, or direct toward resources that can educate, any novice owner who wishes to become involved with breeding and/or showing of the breed.
4. Members shall be familiar with and agree to abide by all Canadian Kennel Club rules and regulations including registration of litters, individual dogs, transfers of ownership and maintenance of accurate records of breeding, pedigrees, and sales.
5. Members shall not sell or supply any dogs or stud services/brood matrons to pet stores, wholesalers, raffles, lotteries, auctions, flea markets, laboratories (unless sanctioned by the CSSA) or as give-away prizes.
6. Members shall not place their own dogs using a Rescue Service.
7. Members shall provide adequate shelter, nutrition, socialization, veterinary care and exercise for their dogs. They shall also make sure that their dogs are maintained in a safe and sanitary environment.
8. Members shall word advertisements so as not to be misleading or misrepresent themselves or their dogs.
9. The overall objective of a member's breeding program shall be to meet the Canadian Kennel Club's standard for the Shetland Sheepdog, and to produce happy, healthy puppies with good temperaments, whether for pet, performance or show. Whenever possible, all breeding stock shall be screened prior to breeding for genetic disorders commonly found in the breed.
10. Breeders shall consider the age, health, and length of time from the bitch's last litter before they breed and shall determine if there is adequate time available to properly socialize new puppies. No bitch should be bred before she has reached twelve months of age, and at breeders discretion not after her eighth birthday,
11. Breeders shall do their best to see that any dog discharged from their care will go to a home that will adequately provide for the health and welfare for the dog, and shall be discriminating in the placement of breeding stock.
12. All contracts, agreements, and guarantees shall be in writing and include all terms agreed upon by the parties at the time of signing. When placing a pet quality dog, a Non-Breeding Agreement should be used. All terms of any signed agreement, contract, or guarantee shall be honoured in full
13. Breeders shall provide purchasers with written details as to the care and welfare of the dog. Permanent identification of dogs, a record of vaccination and a litter pedigree shall accompany each dog before it leaves the premises. It is recommended that puppies shall not be placed before 8 weeks of age, and until having initial immunization.
14. Members shall accept full responsibility for their breeding practices and shall take back any of their dogs whose owner can no longer care for the dog, or shall assist in re-homing said dog, or shall provide financial support to a CSSA recognized Rescue Organization.
15. Failure to abide by this Code of Ethics, and upon proof of such failure, shall result in immediate suspension of CSSA privileges and/or possible termination of membership.
